NOW IT IS HEREBY AGREED AS FOLLOWS:

AREAS OF COOPERATION

SPACC and **ACSCN** agree to the following goals and objectives in order to initiate the academic collaboration programme.

a. Campus Visit

SPACC and ACSCN shall allow research students of the respective institutes to usit their campuses in the format of institute visits (one day visit with an orientation tour and faculty session)

PRINCIPAL

b. Joint Research and Consultancy

SPACC and **ACSCN** will work together on joint research and consultancy projects in specific areas of mutual interest. For this purpose, expenditure incurred at respective will be borne by each. The revenue generated through these projects will be shared equally among the two institutes. The scope of this MOU shall be as follows:

- Joint Research Paper: Faculty from both SPACC and ACSCN will
 work together for writing a research paper, conducting a live
 research projects, funded research project by the various funding
 agencies of university/industry (i.e. University UGC,AICTE, Pvt.
 Organization, Govt. Organizations) and related research activity.
- Student Guidance: Faculty from both SPACC and ACSCN will
 provide cross institutional guidance to the research student of
 PGRC as well as other students. This assistance shall not be
 limited to and include guidance during Summer Internship
 Project, live Research Project, doctoral research and related
 activities.
- Library Sharing: Faculty and Students from both SPACC and ACSCN will have free access to the library and related infrastructure. Party Institutes on a prior notice provide full access to library facility of the other institute for research related work. Library staff from both institutes will conduct regular meetings for exchange of knowledge transfer on latest journals, magazines, databases and developments in library science. The process and policy for assessing study material shall be mutually agreed by the party institutes.
- Designing and conducting course work: Faculty from both SPACC and ACSCN will jointly design and conduct the subject specified course work of regular doctoral programme. Party institutes will also develop study material for the said course work.
- Training on tools: Faculty from both SPACC and ACSCN will
 jointly have training for analytical tools (SPSS SAS) for students of
 party institutes and other institutes as well.

c. Knowledge Transfer (Teaching)

Office

SPACC Faculty will work at **ACSCN** for a period mutually decided upon by the two institutes and contribute in the form of teaching certain modules or topics in an identified course. This in turn will enable the creation of innovative new products, services and policies to be developed.

d. Creating awareness about various programmes offered by both the institutes

space and acscn will exchange all the resources they have with each other for publicizing the information about programmes offered by both the institutes. Space and acscn will exchange all resources they have with each other for publicizing the information about functions, seminars, workshops and symposiums. Faculty members from both institutes will attend faculty development programmes and refresher courses organized in areas of mutual interest.

e. Student Exchange

SPACC and **ACSCN** will extend their resources for 'Student Exchange' programmes. Under this programme, students from one institute can opt for a week of learning at the other institute. The attendance and concurrent evaluation can be shared with the parent institute.

f. Training for Students and Faculty

SPACC and **ACSCN** will design and impart need based training programmes for students and faculty members of both the institutes. A Joint certificate will be awarded on successful completion of training. A pre-decided fee can be charged, which can be decided from time to time.

g. Cultural Programs: SPACC and ACSCN will conduct some cultural programs of the students jointly.

Duration and Termination Clause:

The duration of this MOU will be for the period of three years. The MOU can be extended for further period with same or mutually agreed terms. **SPACC** and **ACSCN** retain the right to terminate this MOU after one year from the date of signing it.
